**MAHR (DOWRY)**

*Mahr* is the consideration for the contract of marriage between the parties. It may be in the form of money and/or goods given by the Bridegroom to the Bride in consideration for the marriage. It is an essential element of Muslim marriage and is exclusively reserved for the use of the female partner. Payment of *Mahr* can be immediate (prompt), or deferred.

*Mu'ajjal* (Immediate/Prompt): This means the total amount of *Mahr* payable by the Bridegroom at the time of signing the marriage contract.

*Mu'wajjal* (Deferred): This means the portion of the *Mahr* which is payable to the Bride at a specified point in the marriage or at the time of dissolution of the marriage through divorce or death of the husband. Any deferred *Mahr* that remains unpaid at the time of dissolution becomes a debt against the former husband's assets.

**ADVANCE REQUIREMENTS (AT LEAST 7 DAYS PRIOR TO NIKAH DATE)**

- Valid passports of the Bridegroom and Bride;
- Original proof of residential address for both Bridegroom and Bride i.e. utility bill, bank statement or council tax bill dated within the last 3 months;
- Conversion certificate where either Bridegroom, Bride or both have embraced Islam;
- Original Islamic divorce or Decree Absolute document if previously married and divorced;
- Original Death Certificate if previously married and widowed;
- Valid passports and original proof of residential address of witnesses dated within the last 3 months;
- Original Civil Marriage Certificate (Where applicable);
- Payment of Nikah fee (£50) in cash.
